- The company has a maximum of 50 employees.

Terms of Participation

Commitment of Participation

Participation at the Future Mobility Award competition organized by Messe Karlsruhe, aen - automotive engineering network e.V. and Nahverkehrs-praxis/ Fachverlag Dr. H. Arnold GmbH, hereinafter referred to as the operator or organizer, is free of charge and is governed exclusively by these conditions of participation.

Procedure of the competition

The period of application to the competition lasts until 01.05.2023 at 23:59. During this period, companies can apply for the competition.

Participation

To participate in the competition, it is necessary to complete and submit the registration form. Participation is only possible within the application period. Applications received after the closing date will not be considered in determining the winners. Only one submitted registration per company and/or participant will be entered into the competition. It is strictly prohibited to use multiple registrations to increase the chances of winning. Participation in the competition is free of charge.

Eligible participants

Companies (natural persons and legal entities operating as companies) that, in the case of natural persons operating as companies, have reached the age of 18 years, are eligible to participate. Participation is not restricted to members/customers of the organizer and does not depend on the purchase of goods or services. The companies must also meet the criteria stated under „Participation Authorisation“.

Not eligible to participate in the competition are all persons involved in the conception and realization of the competition and employees of the operator as well as their family members. In addition, the operator reserves the right, at its own discretion, to exclude persons from participation if there are justified reasons, for example (a) in the event of manipulation in connection with access to or realization of the competition, (b) in the event of violations of these conditions of participation, (c) in the event of unfair practices or (d) in the event of false or misleading information in connection with the participation in the competition.

Terms of Participation

Prize, notification and transmission of the prize

The following prize will be presented:

Main prize for the first place of the competition:
Future Mobility Award 2023 trophy in connection with a prize money of 5000 € (in words: five thousand euros).

The winners will be determined after the closing date by a jury decision in several rounds (final, semi-final, etc.). If the competition is linked to a task, only those participants who have correctly completed the task will be selected by the jury.

The winners of the competition will be informed about the prize in due course in a separate email or via video chat.

The prize will only be handed over to the winner or the winner's legal representative(s). An exchange, a self-collection as well as a cash payment of the prize are not possible.

Any costs incurred for shipping the prizes will be covered by the organizer. Any additional costs associated with claiming the prize shall be covered by the winner. The winner is responsible for any taxation of the prize.

Termination of the competition

The organizer explicitly reserves the right to terminate the competition without prior notice and without giving reasons. This applies to any reasons that would disturb or prevent the competition from proceeding as planned in particular.

Data privacy

Participation in the competition requires the submission of personal data. The participant assures that the information provided by him/her about the company/person, in particular company name/first and last name and email address, is complete, true, and correct.

The organizer points out that all personal data of the participant will neither be passed on to third parties nor given to them for use without consent.

In the event of a win, the winner agrees to the publication of his/her (company) name and registered office as well as photographs and video material taken during the competition in the advertising media used by the organizer. This includes the announcement of the winner on the websites of the operator and its social media platforms.
